**CITY OF MENOMINEE, MICHIGAN
WATERFRONT FESTIVAL
CONCESSION AGREEMENT**

The City of Menominee, Michigan as special Liquor Control Commission licensee, and _____, as a food booth operator, agree as follows:

- 1) The City of Menominee is the sole seller of beer and wine, and will retain all profit derived from those sales.
- 2) The City of Menominee will abide by State law and Michigan Liquor Control Commission rules and regulations during the Waterfront Festival that runs from August 2 through August 5, 2018.
- 3) The City of Menominee will purchase all beer and wine from a State of Michigan licensed wholesaler.
- 4) The food booth operator will have no responsibility concerning the sale or consumption of beer or wine during the festival.
- 5) The food booth fee allows use of the tent, facilities, and electrical power.
- 6) The City of Menominee maintains control and responsibility for the actions of all persons, volunteers, or employees operating under the concession agreement as it relates to the Liquor Control Code and Rules and violations of the Code and Rules.
- 7) The City of Menominee retains control over all portions of the licensed premises.
